

Jacksonville Independent School District Board of Trustees Public Hearing and Regular Meeting May 21, 2012 Minutes

The Board of Education of the Jacksonville Independent School District, State of Texas, met on April 21, 2012 at 6:30 p.m. for a Regular Meeting in the Little Theater of the Jacksonville Middle School located at 1541 Pine Street, Jacksonville, Texas.

1. Call to Order

A. JISD Police Department Report

JISD Police Chief, Marvin Acker, gave a report on the JISD Police Department and School Resource Officer Program. He reported that the department was organized during the 2001-02 school year with a Chief and two officers and then grew to a total of five officers in 2002-03 by means of a Cops-In-Schools Grant. The Department currently consists of four full-time officers who have 72 years of combined experience. He emphasized that the main function of his department is to provide safety and security for the staff and students of JISD and listed specific duties that officers perform daily to maintain safe and secure campuses. The JISD Police Department also oversees student attendance issues and explained that the number of attendance cases filed had decreased significantly this year as compared to the previous years due to a change in legislation. This change excludes school districts from filing attendance cases on students age 18 years and older.

B. Discuss Date, Time, and Location for Summer Board Retreat Mr. Houser discussed with board members a possible date for the Summer Board Retreat for board members to discuss board operating procedures, board code of conduct and other related policies. It was decided to hold the Retreat on Monday, July 9th, at 6:00 p.m. at the JISD Board Room located at the JISD Administration Building.
