Jacksonville Independent School District Board of Trustees Regular Meeting January 25, 2010

The Board of Education of the Jacksonville Independent School District, State of Texas, met for a Regular Meeting on January 25, 2010 at 6:30 p.m. in the Board Room of the JISD Administration Building located at 1547 Pine Street in Jacksonville, Texas.

1. CALL TO ORDER

Board President, James Houser, announced that a quorum was present, that the meeting was duly called, and that notice of the meeting had been posted for the time and in the manner as required by law.

2. RECOGNITION OF 2009-10 JISD BOARD OF TRUSTEES

Dr. Wardell recognized the 2009-10 Board of Trustees and thanked them for their service and dedication to the students of the District. He added that one reason the District has become academically successful is due to the Board's dedication to students receiving a good education. In appreciation of their service each board member was presented with a basket filled with a variety of goodies from the campus to which that board member serves as liaison.

3. REPORTS / DISCUSSIONS

A. Athletic Department Report Update

Coach Steve Wells reported to the Board that 906 (51.3% of the student body) students are currently participating in athletics compared to 826 students at this time last year. He then gave a breakdown of how many students are participating in each sport. Of the 906 students participating, 64 of these students receive Special Education services. Coach Wells concluded his report by providing an overview of procedures that the Athletic Department follows to prepare student athletes for college both academically and for athletic recruitment.

B. JISD Police Department Report

JISD Police Chief, Marvin Acker, gave a report on the JISD Police Department and School Resource Officer Program. He reported that the department was organized during the 2001-02 school year and began with a Chief and two officers. By means of a Cops-In-Schools Grant two more officers were added in 2002-03 bringing the total to five officers. He emphasized that the main function of his department is to provide safety and security for the staff and students of JISD. He then listed specific duties that officers perform daily to maintain safe and secure campuses. The JISD Police Department also oversees student attendance issues.

C. May 8, 2010 School Board Election – Important Dates

James Houser reported pertinent filing dates and voting dates for the May 8, 2010 JISD Board of Trustees Election. The Board will order the election at the February 15, 2010 board meeting; however, the date to begin filing an application to run for the school board begins February 8, 2010 and ends March 8, 2010.

D. Special Election of Region 7 Education Service Center Board of Trustees

Dr. Joe Wardell advised Board members that a vacancy has occurred on the Region 7 Board of Trustees due to the death of a trustee. Region 7 has asked all member school districts to post the vacancy to provide information on filing to run for the position in this special election.

E. Discussion of March Board Meeting Date - Falls During Spring Break After a discussion that the March board meeting date falls during Spring Break, it was decided that March 22, 2010 will be the date for the regular March board meeting of the JISD Board of Trustees.
