Jacksonville Independent School District Board of Trustees Regular Meeting April 19, 2010

The Board of Education of the Jacksonville Independent School District, State of Texas, met for a Regular Meeting on April 19, 2010 at 6:30 p.m. in the Board Room of the JISD Administration Building located at 1547 Pine Street in Jacksonville, Texas.

1. CALL TO ORDER

Board President, James Houser, announced that a quorum was present, that the meeting was duly called, and that notice of the meeting had been posted for the time and in the manner as required by law.

2. PLEDGE OF ALLEGIANCE TO FLAGS

James Houser led the pledges of allegiance to the United States Flag and Texas Flag.

3. AWARDS / ACKNOWLEDGEMENTS

A. Presentation of \$4800 Donation by Kiwanis Club to JISD

Nancy Washburn presented to JISD a check for \$4800 to be used to purchase supplies for Pre-Kindergarten students for the 2010-11 school year. James Houser accepted the donation and thanked Ms. Washburn and the Kiwanis Club for all they do each year to support the students of JISD.

4. REPORTS / DISCUSSIONS

A. JMS Band UIL Results

Joseph Brunson, JMS Band Director, reported to the Board on the recent UIL Solo & Ensemble Contest in which a record setting 92 JMS students participated. Mr. Brunson showed a power point presentation including some of the students expressing their contest experience and what they feel they learned. The presentation also included the following results:

- 15 students earned a "2" = Excellent Rating
- 75 students earned a "1" = Superior Rating

Mr. Brunson expressed his excitement at the participation and results and also thanked the Board for their continued Support. The Board and audience applauded the success of Mr. Brunson and these students.

B. SHAC (School Health Advisory Committee) Report

Stephanie Wofford gave a report to the Board on the current health curriculum that has been established for the students by SHAC. She updated the Board on the District's programs in the areas of health and physical education; nutrition and health services; healthy and safe school environment; staff wellness promotion; and parent and community involvement.

C. Report on Current TEKS for High School Government Classes

Tammy Jones introduced Mike Alberts and Matthew Paulson who teach Government and Economics classes at JHS. Mr. Alberts briefly explained that he lectures rather than use textbooks. His curriculum, while rooted in basic Government principles, also includes current issues. He encourages students with similar opinions to express their viewpoints and form groups, much like political parties. Then, Mr. Paulson added that they also include citizenship and participation in democracy. His class has warm-up periods with lively discussions. Both teachers advised that all seniors are required to study the Constitution.

D. Discussion of FDA(LOCAL) Policy: Admissions – Interdistrict Transfers
Dr. Wardell advised that some board members asked for a review of this
policy. A discussion followed among board members where certain board
members expressed the desire to pursue a possible change in the student
transfer policy to allow out-of-district students to transfer into the district on a
case-by-case basis annually. Currently policy allows incoming transfers
only for out-of-district students whose parent/guardian is an employee of
JISD. Board members requested that this policy be re-visited for
discussion at the next board meeting.

E. May 8, 2010 JISD Board of Trustees Election

James Houser reminded everyone that the early voting period for the 2010 School Board Election is April 26th through May 4th, 8:00 a.m. to 5:00 p.m. (Monday-Friday only) at the Jacksonville Senior Center located at 302 S. Bolton Street. He also reminded everyone that election day will be Saturday, May 8th, from 7:00 a.m. to 7:00 p.m. at the Jacksonville Public Library located at 502 S. Jackson.

F. Discussion of May 17th Board Meeting

Dr. Wardell informed the Board that the May 17th board meeting will be held at the JMS Little Theater to accommodate a larger crowd. That meeting will include JISD employee service and retirement awards.
