Jacksonville Independent School District Board of Trustees Regular Meeting September 20, 2010

A Regular Meeting of the Board of Trustees of Jacksonville ISD was held Monday, September 20, 2010, beginning at 6:30 PM in the Board Room of the JISD Administration Bldg., at 1547 Pine Street, Jacksonville, Texas.

1. CALL TO ORDER

Board President, James Houser, announced that a quorum was present, that the meeting was duly called, and that notice of the meeting had been posted for the time and in the manner as required by law.

2. PLEDGES OF ALLEGIANCE TO FLAGS

James Houser led the pledges of allegiance to the United States Flag and Texas Flag.

3. BLUE RIBBON SCHOOLS ANNOUNCEMENT

Mr. Houser commended all those who planned and executed the Blue Ribbon Celebration held earlier at the Lon Morris Gymnasium honoring West Side Elementary and Fred Douglass Elementary staff and students. He congratulated the administrators and staff of the two campuses for earning this national recognition and honor. Dr. Wardell then presented each principal with a large floral arrangement to take to their campuses to enjoy with their staff and students.

4. REPORTS / DISCUSSIONS

A. Update on District's Technology

JISD Technology Director, Hedda Alexander, gave a report on some of the major activities performed by the Technology Department over the summer. Upgrades were made to the network including 56 switches and a partial wireless network at Jacksonville High School. A major upgrade to the Network Operational Center (NOC) included the installation of a back-up generator to avoid power outages, and an additional air conditioner to avoid overheating of the NOC. The department also performed server virtualization and computer replacement where needed. The JISD Technology Department was also responsible for receiving and preparing over 300 laptops to be provided to 9th grade students under the Vision 20/20 Grant. These laptops will be provided during the school year only to those eligible 9th grade students who attend the training with their parents and pay a nominal fee that covers the cost of reimaging these computers at the end of the year. These laptops are warranted for a four year period.

B. Update on Incoming Student Transfers

Dr. Wardell gave an update on incoming student transfers. Prior to the adoption of the amended FDA(LOCAL) policy at the June 21, 2010 board meeting, only children of employees were permitted to transfer into the district while residing in another district. This amendment allows students residing outside the district who are not children of employees to transfer into the district based on approval

by the Superintendent. The Superintendent's approval or denial is based on space availability and student history. Dr. Wardell added that there were only two students who applied for transfer into the district who were not children of employees. One student is of high school age and was accepted since there was room at that campus. Another kindergarten applicant was denied due to lack of space available. There are currently 36 students transferring into the JISD.
