

Jacksonville Independent School District Board of Trustees Regular Meeting October 11, 2010 Minutes

A Regular Meeting of the Board of Trustees of Jacksonville ISD was held Monday, October 11, 2010, beginning at 6:30 PM in the Board Room of the JISD Administration Bldg., at 1547 Pine Street, Jacksonville, Texas.

1. CALL TO ORDER

Board President, James Houser, announced that a quorum was present, that the meeting was duly called, and that notice of the meeting had been posted for the time and in the manner as required by law.

2. PLEDGES OF ALLEGIANCE TO FLAGS

James Houser led the pledges of allegiance to the United States Flag and Texas Flag.

3. REPORTS / DISCUSSIONS

A. Report on JHS Media Technology Class

Marc McCloud (district PR coordinator) worked with the media students on several projects in the absence of their teacher, Mr. Michael Culotta, who was on medical leave from the District. Mr. McCloud reported that the class, originally proposed in the spring of 2002 by two former JHS technology students, was added to the curriculum in the fall of 2002. Terri Orr began teaching the class until Mr. Culotta was hired in the spring of 2003.

Students in the Media Technology class are using the most advanced computer programs in the District in their project based learning environment. They are involved with real world situations, deadlines, consequences and problem solving skills. These students collaborate on pre-production writing scripts, shot lists, thumbnails, fact-finding, and the "talent". Also, they are involved in post-production activities such as editing and working with clients. Their equipment includes advanced computer software, cameras, microphones, video mixers, audio mixers, digital video editing, virtual sets (green screen), real sets, field interviews, and event coverage.

The media students help produce a lot of the content for JNDN-TV which is viewed on Channel 20 of the local Suddenlink cable network. They produce and film the weekly news program, Smoke Signals. The goal is to have a fully functional television station that is run by students. All aspects of managing a television station fit into the TEKS for the advanced course.

Mr. McCloud reported that the media students performed very well recently under less than ideal circumstances. With their teacher on leave, the students pushed to continue their weekly production and taping of Smoke Signals and also faced the challenges of filming some video special events in the District such as the

JISD Convocation, the Blue Ribbon Ceremony, and a special video project for West Side Elementary called "West Side Story" which had to meet certain criteria in an application process. Mr. McCloud praised the media students for their perseverance and tenacity and for the quality of the work they produced. Mrs. Sandi Jones, Principal of West Side Elementary, also spoke highly of these students and thanked them for accomplishing this wonderful project for them.

B. 2008-09 School FIRST (Financial Integrity Rating System of Texas)
Lindy Finley, Assistant Superintendent of Finance and Operations, presented a
Power Point slide show reflecting the 24 indicators involved in figuring the 20082009 F.I.R.S.T. rating for school districts. For each indicator Ms. Finley
explained the question and the District's response. She reported that JISD
received the highest financial rating of "Superior", a rating that the District has
achieved the past eight years. Included and considered in the F.I.R.S.T. report
are a copy of the superintendent's current contract and a summary of financial
disclosures pertaining to the superintendent and school board.

Ms. Finley further explained that this rating is for the 2008-2009 school year and that the recently completed 2009-2010 school year is currently under financial audit and will receive a rating this time next year.

C. JISD Bond Election

- Dr. Wardell reported that that the November 2, 2010 JISD Bond Referendum has now received public endorsement through proclamations or resolutions from the Jacksonville Chamber of Commerce, JEDCO, City of Jacksonville, Jacksonville Educational Foundation, Lon Morris College, and Jacksonville College.
