### 1. CALL TO ORDER

Board President, James Houser, announced that a quorum was present, that the meeting was duly called, and that notice of the meeting had been posted for the time and in the manner as required by law.

2. PLEDGES OF ALLEGIANCE TO UNITED STATES AND TEXAS FLAGS James Houser led the pledges of allegiance to both flags.

## 3. BOND CONSTRUCTION UPDATE

Jeff Edwards of Claycomb & Associates updated the Board on the construction progress for the two new elementary campus sites:

- Joe Wright Elementary status:
  - Area D & E Piers Complete; Area C Piers 50%
  - o Area D Grade Beams 15%; Area E Grade Beams 15%
  - Sewer Force Main 60%; Site Sanitary Sewer 50%
  - Water Main 25%
  - Next: grade beam construction continues; pier caps; steel delivery and erection
     October 31<sup>st</sup>; underground utility installation; electrical main and transformer
- East Side Elementary status:
  - Area A & B Piers Complete; Area C Section Piers 20%
  - o Area A Grade Beams Complete; Area B Grade Beam Forms Being Erected
  - Area Building Plumbing Rough-In Underway
  - Site Utility Work Starting
  - Primary Electrical Conduit Installed
  - Next: grade beam construction; pier cap installation; steel delivery and erection November 14<sup>th</sup>; underground utility installation

## 4. REPORTS / DISCUSSIONS

A. Update on Incoming Transfers

Dr. Wardell gave the following update on 2011-12 incoming student transfers to reflect the impact on the District since changing the student transfer policy a year ago at the beginning of the 2010-11 school year. Prior to changing policy, JISD allowed only children of JISD employees living outside the district to transfer to JISD.
