

The Board of Education of the Jacksonville Independent School District, State of Texas, met for a Regular Meeting on June 20, 2011 at 6:30 p.m. in the Board Room of the JISD Administration Building located at 1547 Pine Street, Jacksonville, Texas.

Present: James Houser, Joe Casey, Dale Jamerson, Jimmy Brown, Todd Travis, and

1. CALL TO ORDER

Board President, James Houser, announced that a quorum was present, that the meeting was duly called, and that notice of the meeting had been posted for the time and in the manner as required by law.

2. PLEDGES OF ALLEGIANCE TO UNITED STATE AND TEXAS FLAGS

James Houser led the pledges of allegiance to the United States Flag and Texas Flag.

3. REPORTS / DISCUSSIONS

A. Preliminary TAKS Results for 2010-2011

Judy Terry reported the preliminary results of TAKS testing for 2010-11 and added that final results will be available later in the summer. Annual assessment testing includes TAKS, TAKS-LAT, TAKS-Accommodated, TAKS-Accommodated-LAT, TAKS-M, TAKS-M-LAT, TAKS-Alt, and TELPAS. Ms. Terry added that this year's ratings will not be formulated using the TPM (Texas Projection Measure).

B. Auction for JHS 300 Building Contents

Mike Pope gave a brief accounting of the contents from the JHS 300 building that will be demolished for the JHS renovation project. He advised the Board that all contents that will not be used in another location will be auctioned on-line. The exact dates for the on-line auction have not yet been determined.

C. Transportation Department Annual Report

Lindy Finley gave an annual report on the Transportation Department highlighting the total cost of transportation, base cost (including capital outlay net), annual miles driven, cost per mile, and average cost per gallon of fuel. It was noted that;

- the base cost of transportation operations has decreased since JISD reclaimed operation of transportation from Southwest Transportation in 2001-02;
- the route cost per mile had decreased from the previous year; and
- fuel cost had increased from the previous two years but was less than in 2007-08.

Ms. Finley explained that the Transportation Department has become more efficient by plan. Over the last five years JISD Transportation has:

- implemented the student exchange at the JMS campus in the afternoons to avoid each bus stopping at each campus;
- implemented new routing Transfinder software to make routes more efficient;
- adjusted morning student exchanges;
- established a satellite Transportation Department at the Compass Center for southern routes;
- enacted a No Idle Policy; and
- eliminated routes where possible.

D. Food Service Department Annual Report

Clay Carter reminded board members that the district had hired TASBO in 2009 to conduct a Food Service Review. The JISD Food Service Department has addressed all but one of the twelve recommendations by TASBO which is the purchase of a refrigerated truck for transporting commodities from the warehouse to the campus kitchens. With regard to TASBO's recommendations, the department has reduced and rearranged staff and increased the practice of batch cooking and waste monitoring for an approximate savings of \$155,440. Additionally, with an excess of \$169,000 in the Food Service Fund Balance, Mr. Carter reported that he was able to purchase several equipment items for the kitchens that were included in the TASBO recommendations.

Mr. Carter also reported that for 2010-11:

- total meals served annually in JISD cafeterias have increased to 1,040,000 from 940,000 in 2006-07;
- all JISD cafeterias received a 100% on all Fall and Spring health inspections conducted by the county;
- the JISD Food Service Department earned the 2010-11 "Clean Pipe Award" for the second year in a row from the City of Jacksonville for having no wastewater grease violations.

Mr. Carter concluded his report with short term and long term goals for his department. He also reported on new school lunch guidelines and restrictions. He added that effective July 1, 2011 schools are required to charge students for paid meals at a price that is on average equal to the difference between free meal reimbursement and paid meal reimbursement. The USDA will allow school districts to adjust prices in timely increments or at the discretion of the School

Board. His recommendation to the Board at this time is to increase school lunches 5¢ across the board for 2011-12.

5. ACTION

A. Consider and Approve Increase in Lunch Prices Effective 2011-2012 School Year

It was moved by Dale Jamerson and seconded by Blaine Verhelle to approve an increase of 5ϕ in lunch prices for all campuses to be effective for the 2011-12 school year.

B. Review the Bids on the Qualified School Construction Bonds, Adopt the Order Authorizing the Issuance of the Bonds and Take All Necessary Action Thereof

Doug Whitt of Southwest Securities, Inc. presented information regarding the bidding on the sale of the \$7.2 million in Qualified School Construction Bonds. He reported that the District will have net of 0% interest which will save the District approximately \$3.5 million in interest on these bonds. It was moved by Jimmy Brown and seconded by Todd Travis to adopt the Order authorizing the issuance of the Qualified School Construction Bonds, and take all necessary action thereof.

- Contractor Vendor Fair:

 - o Prospective vendors began arriving at 11:30am
 - o Bids on the two elementary schools are due June 30th and we are projecting to have the Guaranteed Maximum Price for the July 18th meeting to present to the Board
