

Jacksonville Independent School District Board of Trustees Budget Workshop and Regular Meeting June 9, 2014 Minutes

The Board of Education of the Jacksonville Independent School District, State of Texas, met on May 19, 2014 at 5:00 p.m. for a Budget Workshop and at 6:30 p.m. for a Regular Meeting in the Board Room of the JISD Administration Building located at 800 College Avenue, Jacksonville, Texas.

1. BUDGET WORKSHOP – 5:00 P.M.

A. CALL TO ORDER

Board President, Todd Travis, announced that a quorum was present, that the budget workshop was duly called, and that notice of the meeting had been posted for the time and in the manner as required by law.

B. DISCUSSION OF ITEMS PERTAINING TO 2014-15 JISD BUDGET Lindy Finley presented an overview of the district's budget process including budget planning as well as state, local and federal revenue funding. She reported the current status of the pending lawsuit against the State on public school funding. Also included was a discussion on the monthly financial reports presented to the Board at each regular monthly board meeting as part of the consent agenda.

Ms. Finley concluded by announcing that she will present a proposed budget for 2014-2015 for discussion at the July 28th Budget Workshop. A final proposed budget and tax rate for 2014-2015 will be presented in a Public Hearing at the beginning of the August 25th board meeting. An action item presented at the board meeting to adopt both the proposed 2014-2015 budget and tax rate.

C. ADJOURNMENT

There being no further discussion or questions, the Budget Workshop was adjourned.

2. REGULAR MEETING – 6:30 P.M.

A. CALL TO ORDER

Board President, Todd Travis, announced that a quorum was present, that the meeting was duly called, and that notice of the meeting had been posted for the time and in the manner as required by law.

B. PLEDGES OF ALLEGIANCE TO UNITED STATE AND TEXAS FLAGS Mr. Travis led the pledges of allegiance to both flags.

C. BOND CONSTRUCTION UPDATE

Dr. Wardell reported that the Guaranteed Maximum Price for the bond construction is on the board agenda for action. If approved, the construction trailers will be

arriving for setup at the two construction sites this upcoming week. Also, the district will move forward with Groundbreaking Ceremonies set for June 24th for Nichols Intermediate School and July 8th for West Side Elementary School.

D. REPORTS / DISCUSSIONS / INFORMATION

1. *Update on 2013-2014 Assessments*Judy Terry presented preliminary JISD state assessment data to the Board:

Looking at all students, JISD beat the state in 15 of the 22 different subjects tested. Finals numbers will be sent to districts in August.

2. Update on District Energy Contract

In May of 2012, JISD signed an interlocal energy agreement with TASB through Direct Energy for a three year period ending in May of 2015. The JISD Energy Committee (comprised of the Superintendent, Director of Purchasing, Energy Manager, and Assistant Superintendent of Finance and Operations) has negotiated a new energy contract for the District. The new contract is with Hudson Energy Services and locks in a rate of .0509 per kwh through 2019.

4. July and August 2014 Board Meeting Dates

Dr. Wardell reminded everyone in attendance that the board meeting dates will not be on the regular third Monday of the month for July and August. The date for the July board meeting will be July 28, 2014 and the August date will be August 25, 2014.

5. Discussion of 2014-2015 Basketball Reserved Seating

Dr. Wardell informed board members that the 2014-2015 JHS Basketball season will consist of 20 nights of home games to be hosted in the JISD Gymnasium. The UIL District Committee again voted to have boys' varsity and girls' varsity district games coincide at the same location on the same night. A discussion followed regarding possible scenarios involving reserved seats for

the season. Dr. Wardell stated that he would take these ideas and put together information on ticket procedures for discussion at the July and August board meetings.

- 1. Consider and Approve Guaranteed Maximum Price for Additions to the Nichols Intermediate Campus and Construction of the West Side Elementary Campus A motion was made by Jeff Horton and a second by Blaine Verhelle to approve the total Guaranteed Maximum Price of \$20,523,895 as comprised of:
 - \$15,670,702 for construction of West Side Elementary School including parking on the south side of the JISD Gymnasium;
 - \$4,403,672 for construction of additions to Nichols Intermediate School;
 and
 - \$449,521 for construction of parking on the north side of the JISD Gymnasium.
