## 1. PUBLIC HEARING ON SCHOOLS F.I.R.S.T. FINANCIAL ACCOUNTABILITY RATING SYSTEM

### A. Call to Order

Board Vice President, Jeff Horton, announced that a quorum was present, that the hearing was duly called, and that notice of the meeting had been posted for the time and in the manner as required by law.

## B. Overview of Schools FIRST (Financial Integrity Rating System of Texas)

Lindy Finley, Assistant Superintendent of Finance and Operations, presented a Power Point slide show reflecting the certain indicators involved in figuring the 2012-2013 F.I.R.S.T. rating for school districts.

### C. FIRST Rating for JISD for 2012-13

Ms. Finley reported that JISD received the highest financial rating of "Superior" for the twelfth consecutive year. Included and considered in the F.I.R.S.T. report are a copy of the superintendent's current contract and a summary of financial disclosures pertaining to the superintendent and school board. Ms. Finley further explained that this rating is for the 2012-2013 school year and that the recently completed 2013-2014 school year is currently under financial audit and will receive a rating this time next year.
